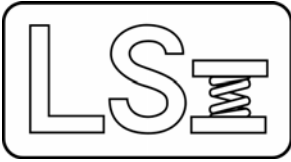

## **Larson Systems Inc. Rental Terms and Conditions**

- 1) Title remains with Larson Systems Inc. at all times. Lessee will keep the equipment free of all liens, levies and encumbrances.
- 2) Larson Systems Inc. will invoice weekly rental fees on terms of Net 10 days. Shipping will be included in the cost of the rental price. The customer will issue a purchase order for the rental of the tester only. Customer is responsible for all taxes and government charges in connection with the rental, possession or use of the equipment. Upon demand, customer must surrender equipment to Larson Systems Inc. if payment has not been received per above terms.
- 3) Rentals shall begin the date of original shipment to the customer and shall end when Larson Systems Inc shipping company picks up the equipment. Rental fees will be billed in full weeks only.  
Example: 1-5 business days equal 1 week, 6-10 business days equal 2 weeks, 11-15 business days equal 3 weeks and so on.
- 4) Unless Lessee gives Larson Systems Inc. written notice of any defect within three days after receipt of a rental item it shall be conclusively presumed that the item was delivered in good condition.
- 5) Larson Systems Inc. warrants that rented equipment meets manufacturer's specifications. No other warranty expressed or implied including without limitation no warranty or merchantability or fitness for any particular purpose shall apply to equipment furnished by Larson Systems Inc. Larson Systems Inc. sole responsibility shall be to repair or replace equipment, which is defective.
- 6) It is the Lessee's responsibility to return equipment to Larson Systems Inc. in the same condition in which it was received, normal wear and tear excepted. Manuals, cables and other accessories, which are not returned, will be billed at current replacement costs. Lessee is responsible for loss or damage to equipment from theft, mysterious disappearance, fire or any other cause. Lessee agrees to pay Larson Systems Inc. new replacement cost of any such equipment, which Lessee is for any reason unable to return to Larson Systems Inc. Lessee, agrees that rental charges will continue until equipment is returned to Larson Systems Inc. for the new replacement cost of the equipment.
- 7) If a printer is required please advise us and one will be supplied with the tester. Should you elect to use your own printers, and make changes to the software, including installing new printer drivers, we will invoice you for service labor hours required to reload software to put the tester back to its original configuration.
- 8) In the event of default by Lessee of any of the above terms and conditions, Larson Systems Inc. shall be entitled to the immediate possession of this equipment and the Lessee gives Larson Systems Inc. permission to enter, with or without process of law, any premises where the equipment may be and, without breach of peace, to take possession of the equipment.
- 9) The rights and liabilities of the Lessee and Larson Systems Inc. shall be determined in accordance with Minnesota law. Lessee agrees that the proper venue for any legal proceeding concerning the rental shall be the County of Anoka, State of Minnesota. Lessee shall pay to Larson Systems Inc. all costs and expenses, including reasonable attorney's fees, incurred by Larson Systems Inc. in exercising any of its rights or remedies with regard to the rental or enforcement of any of these terms and conditions.

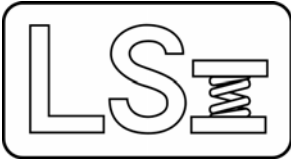
